The FACA Self-Sufficiency Award was established by the Association to recognize and honor achievements by individuals who, with the assistance of a Community Action Agency (CAA), have changed their lives and achieved economic independence.

The FACA Self-Sufficiency Award epitomizes what Community Action is all about: *"Helping people and changing lives"*. Every Community Action Agency has success stories of program participants and this award by the Association seeks to honor those individuals who have turned hope into reality.

Eligibility Criteria

The individual nominated must have:

- Changed his or her life and achieved economic self-sufficiency with the assistance of a Community Action Agency;
- Contributed to improving his or her community through advocacy, volunteerism, public service, or some other vehicle.

Nomination Procedures

FACA members may nominate a candidate by submitting the following:

- The Official Nomination Form;
- A Narrative of no more than two pages demonstrating the nominee's eligibility for this award; and
- Supporting material (e.g., press clippings, articles, letters, or photos).

Please adhere to the nomination guidelines to ensure the candidates eligibility. The nomination packet must include the official nomination form, narrative, and letter(s) of support. If your nominee is selected, the Florida Association for Community Action will request that you provide a three-minute videotape featuring your award nominee. This video of the award recipient will be presented during the 2010 FACA Annual Conference in Jacksonville, Florida.

Selection and Submission Deadline

The Executive Director of the Community Action Agency award recipient will be notified at least one month before the Conference. The Award will be presented during the Conference and nominations must be received by **April 2, 2010** to be considered. The award winner will be invited to attend the ceremony and the Nominating Agency must provide travel for the Award recipient.
