Failure to cancel before the specified date leaves contract term above in full force and effect.

In the event of a loss of grant funding, Customer may cancel Year 3 of the Agreement at Customer's sole discretion, by giving written notice of cancellation to Cvent on or before October 31, 2013. Cancellation has no impact on fees due and payable for Years 1 and 2, but would relieve Customer of any additional liability under this Agreement. Failure to cancel before the specified date leaves contract term above in full force and effect.

Effective 12/11/2011, this Agreement supersedes and replaces the previous agreement between Cvent and Florida Association for Community Action with term dates 12/11/2010 to 12/10/2013 that was signed on 12/9/2010. All sums due under this original agreement executed on 12/9/2010 become due and payable immediately, if Florida Association for Community Action is greater than 30 days overdue on any payments.
